PREFERRED PROTECTION PLAN

To keep your A/C running at peak efficiency, we start with our 17-point precision tune-up.

- 1 Check refrigerant, charge and measure operating pressures and temperatures
- 2 Test compressor operating voltage and amperage
- 3 Check all motors
- 4 Check fan belts and adjust if needed
- 5 Replace standard 1" air filters or wash electronic air cells
- 6 Check condenser coil & clean if needed
- 7 Check and flush condensate drain
- 8 Check electrical connections and wiring
- 9 Check crank case heater
- 10 Check and flush condensate pump
- 11 Test pressure cutout switches
- 12 Check thermostat for proper operation
- 13 Check compressor starting contactor
- 14 Check blower wheel and bearings
- 15 Check condenser electrical disconnect switch
- 16 Check evaporator coil (if accessible)
- 17 Check controls and safety switches

- h. Work performed on non covered parts will be billed at prevailing repair rates
- i. This Plan does not cover parts of labor required as a result of acts of God, fire damage, flooding, damage due to frozen pipes or water, fuel run-outs and power failure. Gault will not be liable for damages that occur due to negligence by the owner or owner's agent from not properly checking an occupied or unoccupied property
